

Solar Cookers International **Agreement for Testing**



Agreement between Solar Cookers International (referred to as SCI) and the customer identified in Section 7 and referred to as Customer, effective _____.

1. Solar Cooker

Customer, at its expense and risk, will provide Customer's Solar Cooker (CSC) – identified in Section 7 – and any cookware (sold by the Customer with the CSC) to be tested, to the location identified by SCI.

2. Testing

Upon SCI's receipt of the CSC and subject to (a) favorable weather conditions and (b) payment by Customer of the fee for testing (as described in Section 3) SCI shall test the CSC in accordance with the ASAE S580.1 protocol for Testing and Reporting Solar Cooker Performance: <https://www.asabe.org/Portals/0/aPubs/S580.pdf>. The testing of the CSC shall normally be conducted within two weeks of SCI's receipt of the CSC. The SCI standard performance evaluation process test station is used for automated, real time data acquisition for wind speed, solar irradiance, geographic position, and ambient and cooking temperatures. Data are stored in a space delineated file on a Secure Digital (SD) card for subsequent post processing. Test equipment is calibrated prior to testing. Data acquisition occurs over the course of three days, not necessarily consecutive, under weather conditions suitable for the testing protocol.

Test results will be summarized and provided in a report (raw data can be provided upon request). The form of the test results shall be substantially as set forth on SCI's website www.solarcookers.org. Results for the testing of the CSC shall be posted on the SCI website if customer notifies SCI in writing to do so within 30 days of receipt of the report. Results are final. Any re-test requires a separate, new testing agreement.

Customer acknowledges that during the testing process the CSC may be damaged and SCI shall not have any liability for any such damage unless such damage was the direct result of SCI's misconduct.

3. Testing Fee

The testing fee is (US) \$1000 per CSC. Customer shall pay the testing fee upon the effective date of this Agreement. Payment can be made by check made out to Solar Cookers International, or by PayPal or credit card. Payment by credit card can be arranged by contacting SCI at: info@solarcookers.org.



4. Return of CSC

The CSC and any cookware provided by Customer will be returned to Customer if specified in Section 7 and Customer furnishes SCI with a prepaid shipping label for such purpose. SCI shall have no liability for any damage to, or loss of, the CSC and any cookware subsequent to SCI's delivery of same to the carrier. If SCI does not receive such instructions within 30 days of the effective date of this Agreement, title to the CSC and any cookware shall be deemed to transfer to SCI and SCI shall have the right to use, sell or destroy same at its sole discretion.

5. Entire Agreement and Notices

This Agreement sets forth the entire understanding of SCI and Customer concerning the subject matter hereof and supersedes any prior oral or written understandings of any nature whatsoever. No amendment to this Agreement shall be effective unless it is in writing, references this Agreement and is signed by SCI and Customer. Notices under this Agreement shall be in writing and if sent to SCI shall be sent via email at info@solarcookers.org with "test request" in the subject line, and if sent to Customer as set forth in Section 7.

6. Limitation of Liability and Governing Law.

SCI's liability under this Agreement for any breach of this Agreement shall not exceed the amount paid by Customer to SCI, and in no event shall SCI be liable for any incidental or consequential damages of any nature whatsoever for any reason whatsoever. This Agreement shall be governed by the laws of California, without regard to the conflict of law's provisions thereof.
